Section 5 – Suspension and revocation	<ul> <li>Continuous Certification was introduced on 1 July 2020.</li> <li>Reinstatement of certification following revocation can now occur after a period determined by the NHMRC on a case by case basis. Further advice on the process will be provided as required.</li> <li>5.1.1 - the HREA has replaced the NEAF for ethics review submission.</li> </ul>
Section 6 – Renewal of Certification	<ul> <li>Continuous Certification has replaced the process of certification renewal.</li> <li>The desktop assessment, previously completed at renewal, has been replaced with periodic monitoring. Monitoring requests may vary over time and will be communicated to institutions in advance. Ongoing monitoring will continue to align with the Assessment Criteria outlined in Appendix 9.1.</li> <li>Changes to categories included under an institution's certification is possible, please contact <u>HREC.admin@nhmrc.gov.au</u> for further advice.</li> </ul>
