## Translating Research into Practice (TRIP) Fellowships Recommended For Funding Commencing in 2019

## **About the Scheme**

The TRIP Fellowships scheme is a two-year part-time Fellowship providing protected time to support future leaders to implement established evidence into practice.

The specific objectives of the scheme are to:

- build capacity in research translation by supporting future leaders to undertake projects focused on translating robust or best-available evidence into practice that will either have localised health benefits to patients or broader and deeper impacts on health care, the health system, public health, national policy, and/or service delivery
- create a critical mass of experts in the area of research translation to support and sustain change in the long term.
