

# Postgraduate Scholarships for funding commencing in 2019

The Postgraduate Scholarship scheme provides funding for successful applicants to attain a research based postgraduate degree (Doctor of Philosophy or Research Masters degree).

The major objectives of the scheme are to train outstanding health, medical and dental graduates early in their career so they can conduct research that is internationally competitive, and to develop a capacity for original independent research in Australia.

Postgraduate Scholarships are very competitive and offered to a limited number of graduates of outstanding ability who wish to make research a significant component of their career. This year NHMRC received 227 Postgraduate Scholarship applications of which 78 were successful.

The applications listed in the table below have been approved for funding by the Minister for Health, the Hon Greg Hunt MP.
