

2023 Partnership Projects Peer Review Cycle 1 for funding commencing in 2024

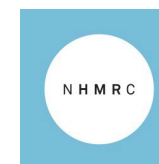
The Partnership Project funding scheme supports connections within the Australian context that translate research evidence into health policy and health practice, to improve health services and processes.
